Item 4. OWNERSHIP.

The information as of the date of the event which requires filing of this statement required by Items 4(a) – (c) is set forth in Rows 5 – 11 of the cover page for each Reporting Person hereto and is incorporated herein by reference for each such Reporting Person. The percentage set forth in Row 11 of the cover page for each Reporting Person is based on 37,629,343 shares of Common Stock issued and outstanding as of May 7, 2020, as represented in the Company's Prospectus Supplement on Form 424(b)(5) filed with the Securities and Exchange Commission on May 7, 2020, and assumes the exercise of the Company's reported warrants (the "Reported Warrants") and the conversion of the reported notes (the "Reported Notes") subject to the Blockers (as defined below).

Pursuant to the terms of (i) the Reported Notes, the Reporting Persons cannot convert the Reported Notes to the extent the Reporting Persons would beneficially own, after any such conversion, more than 4.99% of the outstanding shares of Common Stock (the "Note Blockers") and (ii) the Reported Warrants, the Reporting Persons cannot exercise the Reported Warrants to the extent the Reporting Persons would beneficially own, after any such exercise, more than 4.99% of the outstanding shares of Common Stock (the "Warrant Blockers" and collectively with the Note Blockers, the "Blockers"), and the percentage set forth in Row 11 of the cover page for each Reporting Person gives effect to the Blockers.
